#### **SOLICITING SCAM ALERT!**

If young men or women come through selling books for Texas Children's Hospital with a company called Experience Sales it is a SCAM! I would recommend contacting the police if they come by to keep them from venturing through our neighborhood once and for all!

#### COMCAST/XFINITY SERVICE

Comcast/Xfinity has come through and set up a few homes on Country Forest Drive with cable, phone and internet service! HOORAY! If a little green box was put in front of your home, call them at 1-800-266-2278 and select prompts for New

Service/Sales. You can look online for their available services and pricing specials and sign up for service there.

If you DO NOT have a little green box, follow the same call instructions and they will check your address. If you are not in their system, they can put in a Serviceability Request and let you know if/when service can be provided at your residence. The more people that call to request service the better-so they will be encouraged to extend the service further into the neighborhood. Also, with existing AT&T customers switching to Xfinity internet, it may free up connections with AT&T for DSL service.

#### **PREVENTING LATE FEES**

Is your account past due?

You can prevent the late fee of \$25 per month by paying your account in full before the next monthly billing or calling JDH to set up a payment plan.

# From the Kitchen of Ree Drummond (variation)

#### CHEESY GARLIC PULL-APART LOAF

Temperature: 350 degrees Baking Time: 25 minutes + 10 minutes

1 large round loaf of sourdough or white bread

1/2 cup each-shredded mozzarella, fontera,& romano cheeses1 stick butter, melted1 TBS crushed red pepper3cloves roasted garlicBlack Pepper to taste

Cut bread into a crisscross pattern (grid) from the top but not cutting all the way through the bottom. Place on a large piece of aluminum foil that will eventually wrap up around the entire loaf for baking.

Mix cheeses, peppers and garlic together in a bowl. Fill the cut openings in the loaf by gently stuffing the mixture down into the crevices. Drizzle the melted butter over the entire loaf letting it drip down through the cheese/pepper/garlic mixture.

Wrap the foil up around the top of the bread and bake in the oven for 25 minutes. Uncover and bake an additional 10 minutes. Serve warm.
